#### **COURSE DESCRIPTION**

This course is devoted to exploring the ins and outs of feature film screenwriting, with emphasis shown to the crime genre. Through the exploration of the craft, students will acquire an in-depth knowledge and understanding of how to develop a screenplay from core idea to fully finished screenplay.

# **COURSE OBJECTIVES**

The course will combine analytical and practical approaches to learning with the objective of giving students a comprehensive understanding of the craft of screenwriting. Students will be given tasks each week based on the content of the class. Every student will develop a logline for an idea they have and from that a synopsis and a breakdown of the beats of the story which will give an understanding into how to develop a screenplay.

Students who complete this course will learn about script formatting and all the different elements of the craft such as character development, master plot building, writing dialogue and choosing your genre. We will examine the different techniques which can be used affectively in breaking down a screenplay into parts such as the Three Act Structure, The Five Act Structure and the eight Sequence Approach.

# **COURSE LEARNING OUTCOMES**

Upon successful completion of this course, you will • Learn about the craft of screenwriting • Understand how to develop an idea and a character • Develop an understanding of the screenwriting process • Cultivate a writing practice • Use screenwriting software and understand about screenwriting format • Hone film script analysis skills

# INSTRUCTIONAL METHODOLOGY

This course will be taught with lectures, discussion, student presentations, and group screenings. It will combine analytical and practical approaches with students being given tasks each week based on the content of the class. Every student will develop a logline for an idea they have and from that a synopsis and a breakdown of the beats of the story.

At the end of the course students will have written a short screenplay ready for production, using all the knowledge they have acquired on the course.

Text and video clip examples will be utilized in the analysis and to give students a better understand of each topic discussed. Student participation and discussion is very much encouraged.

# **METHOD OF EVALUATION (GRADING)**

Students will be asked to submit 3 pieces of the duration of the course. The first is the logline which is breakdown of the story idea. Then a treatment of the short script is required. The treatment should be 1-2 pages max and this will be an extended description of the whole story, focusing on the key characters. Finally, in the final class students will present their finished short film screenplay, ready for assessment.

Students will be graded on the following: Class attendance, participation, required documents, final screenplay and engagement.
